INCIDENT RESPONSE MODEL**

(Note: Response Level selected is dependent upon severity of incident)

ALCOHOL/SUBSTANCES

LEVEL 1:

- ❖ CONDUCT PROBATION
- ❖ REQUIRED WORKSHOP *(AN ADMINISTRATIVE CHARGE OF \$50 IS ASSOCIATED WITH THIS CONDITION OF CONDUCT PROBATION)*
- ❖ PARENTAL NOTIFICATION
- ❖ COMMUNITY SERVICE *(FRESHMAN STUDENTS WHO RESIDE IN A LLC)*

LEVEL 2:

- ❖ CONDUCT PROBATION EXTENDED
- ❖ ALCOHOL/SUBSTANCE INTAKE MEETING WITH THE ALCOHOL/OTHER DRUGS COUNSELOR *(AN ADMINISTRATIVE CHARGE OF \$100 IS ASSOCIATED WITH THIS CONDITION OF CONDUCT PROBATION)*
- ❖ MAY BE RESTRICTED FROM RESIDING IN AND ENTERING ALL RESIDENCE HALLS/STUDENT TOWNHOMES
- ❖ PARENTAL NOTIFICATION
- ❖ COMMUNITY SERVICE *(REQUIRED WHEN THE INCIDENT INVOLVES AN ALCOHOL/SUBSTANCE HOSPITAL TRANSPORT)*

STUDENTS WHO ARE PLACED ON CONDUCT PROBATION FOR AN ALCOHOL/SUBSTANCE TRANSPORT WILL BE REQUIRED TO COMPLETE AN ALCOHOL/SUBSTANCE INTAKE (AN ADMINISTRATIVE CHARGE OF \$100 IS ASSOCIATED WITH THIS CONDITION OF CONDUCT PROBATION). IN ADDITION, STUDENTS WILL BE REQUIRED TO COMPLETE A COMMUNITY SERVICE PROJECT THROUGH THE HEALTH PROMOTION AND PREVENTION SERVICES OFFICE.

LEVEL 1:

- ❖ WRITTEN OFFICIAL WARNING

LEVEL 2:

- ❖ CONDUCT PROBATION

LEVEL 3:

- ❖ CONDUCT PROBATION EXTENDED
- ❖ MAY BE REASSIGNED TO A DIFFERENT RESIDENCE HALL/
STUDENT TOWNHOME
- ❖ EQUIPMENT STORED

FILE SHARING/ILLEGAL DOWNLOADING

LEVEL 1:

- ❖ WRITTEN OFFICIAL WARNING

LEVEL 2:

- ❖ WRITTEN OFFICIAL WARNING

LEVEL 3:

- ❖ CONDUCT PROBATION
- ❖ MAY HAVE INTERNET SERVICE TURNED OFF FOR A SPECIFIC PERIOD OF TIME

LEVEL 4:

- ❖ CONDUCT PROBATION EXTENDED
- ❖ MAY HAVE INTERNET SERVICE TURNED OFF FOR AN EXTENDED PERIOD OF TIME
